City of Las Vegas Charter 4.020(4.) charges the Chief Judge of the Las Vegas Municipal Court with establishing and enforcing administrative regulations for the governing of the affairs of the Municipal Court.

On March 12, 2020, Governor Steve Sisolak declared a state of emergency in Nevada in response to the recent outbreak of the Coronavirus Disease (COVID-19). Given the severity of the risk posed to the public by COVID-19, actions taken by the Supreme Court of Nevada, the Eighth Judicial District Court (Administrative Order 20-01) and Justice Court, Las Vegas Township (Administrative Order 20-02); the Chief Judge of Las Vegas Municipal Court has determined that alterations to court procedure are necessary for the protection of the community.

Effective March 16, 2020, Municipal court will accept court filings and continue to operate managing cases within the parameters set forth in this order.

1. In-custody transport of defendants will be suspended for 30-days. In-custody arraignments, pre-trials and trials will be accommodated through telecommunication and/or video conferencing.
2. All arraignments (traffic and criminal) currently scheduled between March 16, 2020 through April 16, 2020, will be continued for a period of 30-days.
3. Defendants arrested on traffic offenses and/or warrants subject to release under the current pretrial procedures will be given a return date of 45 days.
4. Out-of-custody trials (traffic and criminal) scheduled between March 16, 2020 through April 16, 2020, will be continued for a period of 45-days.


1 5. In order to reduce social contact, Municipal Court encourages use of electronic communications for the
2 resolution of cases, status checks, pretrials, and/or negotiations.

3 6. Domestic violence and Driving under the influence classes will remain as scheduled. All other classes
4 will be continued for 30-days.

5 Additionally, the Center for Disease Control has advised people to take precautions and that the best way
6 to prevent illness is to avoid exposure. To assist all persons unable to enter the court facility because of exposure
7 or illness they may call 702-229-5257 to speak to a representative for assistance in rescheduling their court
8 appearance, arranging for appearance by alternate means or provide other information based on the
9 circumstances of the appearance.

10 This Order shall be reviewed no later than every 30-days and shall continue until modified and/or rescinded
11 by a subsequent order.
